- Space is allotted on a first come first serve basis space is allocated on a front footage basis with a minimum of allocation of 8 feet and a maximum of 16 feet per vendor.
- Fee grants space rental for entire length of event.
- Insurance is required for each vendor. You must enclose a copy of valid insurance certificate with this application.
- Applications not accompanied by a valid certificate of insurance will not be accepted.
- Applications submitted without proper payment will not be accepted.
- Vendors will be allowed to set up the day of the event at 6:30 AM.
   Set up should be completed by 10AM. (The time the event begins.)
   Tables that are left vacant after 8:00 AM will be considered a no show and table will be sold to vendors on the waiting list.
- Vendors are expected to stay open until at least 7:30pm or as long as there's enough light to continue transactions. Vendors are expected to start to pack by 8:00pm.
- Vendors are responsible for running their table.
- The Taste of Montclair will have on-site security but is not responsible for any damage and/or theft to or from your booth.
- Vendors are responsible for bringing their own extension cords for electricity. Minimum of 50' of extension cord(s).
- Vendors will not be allowed to sell any food or beverages during the event.
- After August 1st, 2011, all vendor booth fees are non-refundable.
  If a vendor wishes to cancel this agreement the cancellation must
  be made in writing and received by Nick Bosco Design c/o The
  Taste of Montclair no later than August 1st, 2011. Only cancellations
  received prior to said date will receive a refund.
